Terms and Conditions

1. Payment terms are NET-30. Payment is due 30 days after the signing of this agreement. Late fees may be assessed on past due invoices.
2. Exhibitor and Sponsor opportunities are subject to limited availability. Applications will be accepted on a first-come, first-served basis.
3. Restrictions on Operation of Exhibits. The BlueCows Event Foundation (hereafter known as "BCEF"), its trustees and its representatives reserve the right to restrict or remove any exhibit which does not meet the operational guidelines of the St. Louis Union Station Marriott (hereafter known as "Venue") or the BCEF. These guidelines may include, but are not limited to: Excessive noise, explicit or unlawful methods of operation of materials, or other offensive or damaging practice. In the event of such a restriction or removal from the exhibition, the BCEF is not liable for any refunds, rentals or other expenses incurred by the Sponsor or Exhibitor.
4. Care of Exhibit Location. The Sponsor or Exhibitor shall not damage or deface the walls, floors or other facilities, the tables, equipment or other items provided by the BCEF or the Venue. The Sponsor or Exhibitor shall be liable to the owner of the property damaged.

5. Catastrophes. In the event of war, fire, strike, government regulation, public calamity, act of God or other cause, the Conference or any part thereof is prevented from being held, or is canceled by the BCEF or the Venue, the BCEF shall determine any refund to the Sponsor or Exhibitor, after deducting any expenses incurred by the BCEF. Under no circumstances shall the amount of any refund exceed the fees initially paid by the Sponsor or Exhibitor.

6. Liability and Insurance. The Sponsor or Exhibitor shall assume responsibility for, and agrees to indemnify the BCEF and the Venue against, any claims or expenses arising out of the use of the Conference premises. The Sponsor or Exhibitor understands that the Venue maintains no insurance covering the Sponsor's or Exhibitor's property, and it is the sole responsibility of the Sponsor or Exhibitor to obtain such insurance.

7. Cancellations. Cancellations made by the Sponsor or Exhibitor are liable for 50% of the fee indicated herein up to 30 days before the Conference start date. Cancellations will not be accepted after that time and no refunds shall be given. All cancellations must be made in writing to the BCEF, and must be received 30 days prior to the start of the Conference, or earlier, to be considered eligible for partial refund.
